All applicants must have completed all requirements for the doctoral degree except their dissertation. We evaluate applicants on several criteria which include the total number of assessment/intervention hours, psychotherapy hours, number of integrated assessments, letters of recommendation, theoretical proficiency, cultural awareness and writing ability, among others. Competitive candidates will have experience in whichever track they apply for.

Kaiser Permanente Roseville Mental Health and Wellness Internship was established in August 2024 and was granted "Accredited, on Contingency" status by the APA Commission on Accreditation in June 2025. Each application is evaluated in its entirety. There are no mandatory thresholds in any individual category. However, as a general guideline, a minimum of 200 hours of assessment and 500 hours of therapy practica in clinical psychology is considered competitive. These do not need to be direct face-to-face hours and can include time in supervision and support activities (e.g., report writing). Successful applicants have a strong background in psychological assessment and individual psychotherapy, experience with both individually and culturally diverse clientele and an interest in working in a large healthcare care setting.
