Interns interested in training with the Kaiser Permanente Santa Rosa Health Service Psychology Doctoral Internship, who like to work in an integrated health care setting, with a multidisciplinary team, providing empirically supported treatments to a wide variety of patients would fit well in our teams. The SRO Internship is an APA accreddited year long internship, providing 2000 hours of supervised professional experience. Each intern will be placed in 2 of our 3 tracks offered (adult, child, and addiction medicine services) and will remain in those tracks concurrently throughout the training year. Interns engage in 20 hours a week of direct patient care. Weekly supervision, 2 hours each for individual, group and testing. The internship employs a combination of in person and remote telecare practices. Other training experiences include: ADHD assessments (child/adult), supervision of practicum externs, community benefit hours and focused diversity training.
