setting. We provide opportunities to work with adults and adolescents in both group and individual formats, Interns complete 8-10 full adult assessment batteries during the year ranging from ADHD clarification to general psychological/personality functioning. Supervision includes weekly: 1-2 hours of individual clinical supervision (depending on rotation assignment), 1 hour of individual assessment supervision, 1 hour of group clinical supervision and 1.5 hours of group assessment supervision. Didactic presentations are held for 2 hours weekly and draw from a large pool of psychologists and topics. Currently, major rotations offered are: Adult Clinic, Health Psychology, Intensive Out-patient Program - Adults and Intensive Out-patient Program - Adolescents. Interns are assisted in selecting 2 major rotations which run concurrently throughout the internship year. Interns rotate sequentially through 2-3 minor rotations to add to a breadth of exposure. These can include any of about 15-20 groups, Addiction Medicine Recovery Services or ADHD assessment group for children/adolescents. Interns have a compensation package complete with 8 paid holidays, an additional 10 paid days off, paid dissertation defense day off, health insurance (intern and legal dependents), dental insurance (intern and legal dependents), up to \$3,000 tuition reimbursement for covered expenses, is
